Section 1: Fill in all necessary fields: **Name and Mailing Address**

Section 2: Fill in **Destination**—where you are planning to go. (**Location of camp or campsite**)

Purpose—what you are doing (**Camping, fishing, canoeing, hunting, etc**)

Visiting a lease—person whose lease/camp you are visiting

Section 3: Fill in the **Checkpoint** that you are entering, (i.e. 6 mile, Caribou, Little Black etc.)

Dates In and Out

Vehicle information—Plate, Make and Color

Total in Party- (Including, those under 18 and over 70)

Section 4: Fill in any pass information (**Season, annual, L or Guest and complimentary**)

Sections 5 and 6: Resident and Non-Resident Camping

Permittee is allowed to occupy the described site for the time period indicated with temporary movable living quarters for the private camping/recreational use of the permittee only, and the permittee agrees to occupy only the site described.

Permittee agrees to abide by all State and local laws and the rules and regulations of North Maine Woods Organization relating to fire, disposal of trash, refuse and sewerage, and also agrees to make no unnecessary changes or alterations in the appearance of the site and the area.

All personal property not removed from the site at the expiration of this permit will be removed by North Maine Woods Organization at said permittee's expense. In the event that the permittee fails to reimburse North Maine Woods Organization for the expense of removing personal property from the site, said property shall become the property of the permittors without further act, notice, cost or liability of said permittors.

If the permittee fails to abide by all State and local laws, rules and regulations of the permittors or North Maine Woods Organization and the conditions contained in this permit, permittors may cancel or terminate the permit or any part thereof without notice.

In the event of dangerous forest fire conditions, North Maine Woods Organization reserves the right to cancel this and all fire and camping permits without notice.

Permittee agrees that the permittors, the North Maine Woods Organization and the owners of real property represented by said Organization shall not be liable or held responsible in any manner, and permittee agrees to hold harmless and indemnify said Organization, owners and permittors for any injury, damage, accident or harm to the person, property, guests, employees, invitees, agents or family of the permittee arising out of or in any way connected with the use, occupation or visitation by the permittee, his guests, employees, invitees, agents or family of the described site or any land or property of the owners or permittors. Permittee further agrees to indemnify and hold the permittors, North Maine Woods Organization and said owners, harmless against any and all claims, suits, damages, or causes of action of any nature whatsoever by any person arising out of or in any way connected with the use, occupation or visitation of the described site or any land or property of the permittors or owners, or by any other acts or failure to act, by permittee, his employees, invitees, agents or family. The foregoing indemnification shall include without limitation the costs of defending any such claim including reasonable attorney's fees.
